THIS DEED OF TRUST executed on the 8th day of August 1949, By (1) Sri.N.VIJAYAN Son of Late NATARAJAN aged about 37 years, residing at No.6, NataraJ Nagar, Madras-73, (2) Smt.MUZHUMATHI Wife of Sri.N.VIJAYAN aged about 29 years, residing at No.6, NataraJ Nagar, Madras-73, (3) Sri.N.S.S.MOORTHY Son of Late MOORTHY, aged about 50 years, residing at 29, I.O.B. Colony, Madras-73, hereinafter referred to as to the TRUSTEES:

WHEREAS the TRUSTEES herein have agreed and decided to form a TRUST among themselves and to register the same as a PUBLIC CHARITABLE TRUST:

NOW THIS DEED OF TRUST WITNESS AS FOLLOWS:

1. The name of TRUST shall be "VIJAY'S EDUCATIONAL TRUST"
2. The Office of the TRUST shall be located for the present of NataraJ Nagar, Madras-73 and the same may be shifted to any other place as TRUSTEES may decide from time to time.
3. The TRUST shall be a non-profitable organisation.
4. The TRUSTEES shall held office on Honorary basis and are not entitled to any remuneration, anynature.
5. Each TRUSTEES shall contribute a sum of Rs.101/- (Rupees one hundred and one only) as their contribution for the trust and this amount of Rs.303/- (Rupees Three hundred and three only) will form part of the trust founded and named above.

Institutions and centres for the purpose of the objects of the TRUST.

- v) To purchase Technical Instruments, apparatus, computers Scientific medals, illustrations, drawings, maps charts and other equipments to demonstrate and explain technical knowledge among the students and others.
- vi) To purchase catalogue books, periodicals, LITERATURE, BROUGHERS, Souveniers, magazines, research thesis, manuscripts and records on technical and scientific subject for imparting latest developments and research on them.
- vii) To maintain and conduct libraries reading rooms and recreations centres for the benefit of all student and scholars.
- viii) To conduct lectures, seminars, conference and meetings on technical and scientific knowledge.
- ix) To Institute medals, Scholarship prizes, competitions, examinations debates an exhibitions to propogate and encourage scientific and technical knowledge among students and public.
- x) To raise funds by way of collections, donations, subscriptions fees, contributions, endowments, gifts, charity shows, grants, subsidies, loans borrowings and other appeals for the further care and fulfilements of the objects of the TURST:

- xi) To co-ordinate bifucrate of merge with any other institutions or body having similar objectives.
- xii) To do such other things or engages in such activities conducive or incidental to the attainments or further care of the objects of the TRUST:

7- The TRUSTEES shall have the absolute right; authority and privilege to apply the income profits, funds and properties of the TRUST in any manner they like for carrying the objects of the TRUST in any where in Tamil Nadu. All rights and privileges of the Trust including admission to the institutions managed by the TRUST shall be equally divided among all the TRUSTEES shall without any priority of favouritism.

9. The total number of TRUSTEES at any time shall not exceed five. The Trustees shall hold office for life.

10. Among the trustees there shall be one chairman, one secretary and one treasurer. All the Officer bearers shall hold office for calendar year and thereafter the office shall be held on rotation cycle basis thereby giving opportunity for all the TRUSTEES to hold various offices each year. There shall be no ELECTION OR NOMINATION FOR THE POST OF THE OFFICE BEARER. The FIRST OFFICE BEARER FOR THE YEAR- 1989 shall be as follows;

1. Sri.N.VIJAYAN
2. Srimathi.MUZHUMATHI,
3. Sri.N.SS.MOORTHY

10. In the event of any vacancy of the board of TRUSTEES due to death resignation of the TRUSTEE being declared insolvency then the vacancy shall be filled by the nominee of the TRUSTEE and if there is no nominee then the same shall be filled up by consensus among the remaining trustees;

11. All the funds of the TRUST shall be deposited in any branch of any bank as the TRUSTEES ANY DECIDE AND THE BANK ACCOUNT shall be operated by the correspondants along any one of the other Trustees. THE TRUSTEES MAY DECIDE FROM TIME TO TIME TO CHANGE THE BANKERS OR FOR DELEGATING POWERS. And for any two trustees to operate the bank account.

12. The trustees shall hold and or passes all the Trust properties funds other belonging upon trust shall hold and stand possessed of the trust fund upon trust to manage the trust fund and collection all

dues rents dividends, interest and other income there of and to pay all expenses of collection and all expenses and outgoings and to utilise funds of the Trust for any or all the objects of the Trust.

13- The Trustees at any time may invite, advertise or solicit and receive or relieve any such invitations any voluntary donations grants subsidy, contributions legacy from public Government Voluntary organisation for all or any of the objects and purposes of these presents provided that such acceptance is not inconsistent with the object of the trust, any such contribution may be in the form of money, kind security or other movable or immovable properties and without any special condition as may be agreed with the donors and the Trustees.

14. The Trustees shall have all rights and are entitled to appoint or dismiss any person or an official, employees or servant for the trust or for any institution by the trust.

15- The Trustees have all powers to borrow moneys from banks, corporation or from any other person for the genuine requirements of the trust and for the exercise of such powers a may charge or mortgage creates a lien on any of the trust proportion for the purpose of repayment of such loan. Any trustees are empowered to sign such documents on behalf of the trust for the creation of such mortgage or lien on the Trust Properties.

16. The trustees shall be at liberty to keep the TRUST funds in their present form of investment for any such time as the Trustees may think fit and proper and they are all answerable and accountable only to each other and not to any other person, body or institution for such acts.

17. The trustees are at liberty to settle any claim award, arbitration demand as they think fit and proper and may complain or write off any dues to the trust without assigning any reason.

18. The trustees are chargeable only for the funds and income including money, stocks, funds, shares properties and securities as they shall respectively sign and keep for confirmity and shall be answerable and accountable only for their own acts, deeds receipts and neglects or defaults and not for these or the others or other of them nor for any banker, broker, auctioner, or agent or any other person with whom or into whose hand any TRUST FUND or TRUST INCOME may be deposited or came for purchasing or acquiring any property or any security with less than market price or marketable title nor in the insufficiency or deficiency

received stores or funds or shares or securities nor for any less what so even unless the same shall happen due to their own wilfull default of dishonestly and not. Trustee shall take any steps or action against a co-trustee for any breacher alleged breach of trust committed by such co-trustee,

This trust shall be and remain irrevocable for all times.





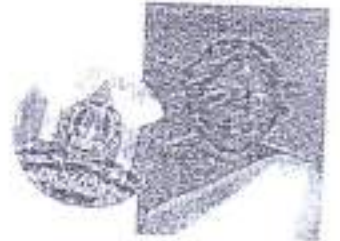
